## **Eighth Training of Public Information Officers (PIOs)**





The KP Judicial Academy organized eighth session of 2-day (9-10 September, 2014) training for Public Information Officers (PIOs). The present was last in the series of trainings initiated by the Academy on the request of the newly constituted Provincial Information Commission, Government of KP. The PIOs are designated under the KP Right to Information Act, 2013. The batch consisted of officers from Home Department including Police and Public Safety Commission. The training aimed at sensitizing the PIOs to their new responsibilities under the new law. It also touched various other relevant aspects, such as, the human right dimension of the right to information and its Islamic perspective. The course focused on the practical aspects of access to information. It is expected that the course will help build capacity of the PIOs in the effective implementation of the law, encouraging accountability and transparency in the long run. A total of eight batches, each comprising of 50 PIOs received the training.

## **Second Training on Case & Court Management for Judicial Officers**

# **KP** Judicial Academy Actively Participates in International Judicial Conference in Qatar

#### 28-29 September, 2014

The Khyber Pakhtunkhwa Judicial Academy actively participated in a 2-day international

Conference on Development of Justice Institutions and Judicial Education, held at Doha, Qatar.

The Conference held on 28-29 September, 2014, at the Qatar's Rule of Law Centre. It was organized by the United Nations Development Program, in collaboration with the KP Judicial Academy, the Qatar Rule of law and Anti-Corruption Centre and the Palestinian Judicial Institute.



The conference was captioned as: Judicial Education's Challenges and Opportunities—the Way Forward through Comparative Experiences from Pakistan, Palestine and Qatar. The Peshawar High Court nominated Judicial Officers, participated in the Conference were Mr. Hayat Ali Shah, Director General, KP Judicial Academy, Dr Khurshid Iqbal, Dean of Faculty, KP Judicial Academy, Mr. Qalandar Ali Khan, District & Sessions Judge/Chairman, KP Service Tribubal and Mr. Muhammad Azim Khan Afridi, District & Sessions Judge, Haripur. Similarly a three-member UNDP team was also participated in the said Conference, they were Miss Shahzia, Rule of Law Specialist, Qazi Jamil-ur-Rehman, National Training Specialist, and Mr. Ashraf Khan.

The Objectives of the Conference were to Call attention to the importance of judicial education among senior echelons of judicial policymaking and practice in participating countries; Identify key challenges in the way of establishing effective, efficient and institutionalized judicial education systems in participating countries and posit innovative solutions; Discuss key measures required at the national and international levels to promote and strengthen judicial education and secure formal commitments by participating institutions to contribute toward their implementation; and Provide ongoing opportunities for sharing learning experiences, cross-fertilizing ideas, exchanging solutions, and pursuing education for judicial officers across the participating countries. Moreover the Themes of the event were Judicial Education: Philosophy and Rationale, Design of Judicial Education and Structure of Judicial Education and its implementation Environment.

In a multimedia presentation, Dr Khurshid Iqbal, Dean of Faculty, spoke on the theme. The focus of Dr Khurshid Iqbal was on mainstreaming judicial ethics in judicial education.
