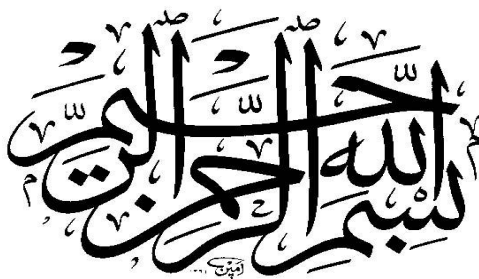

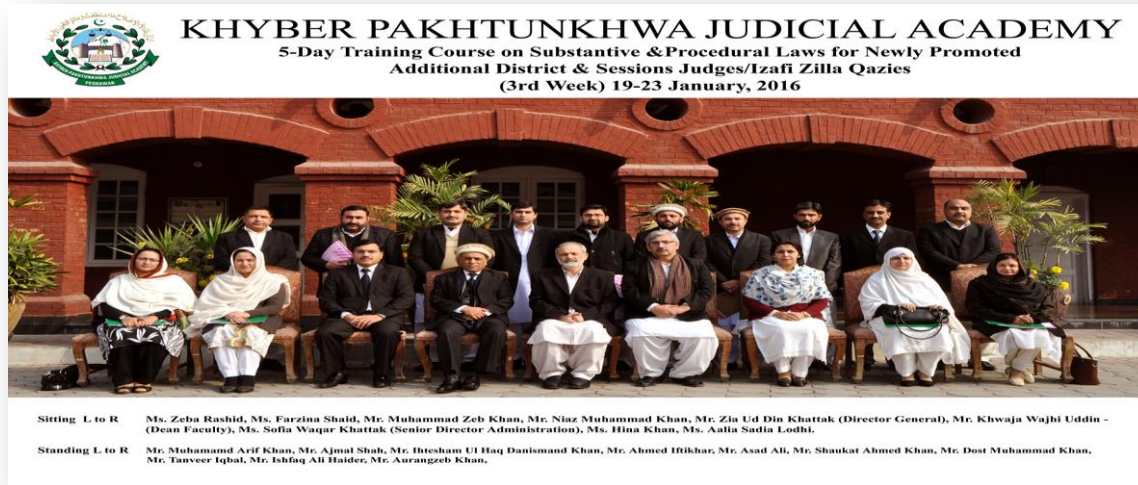

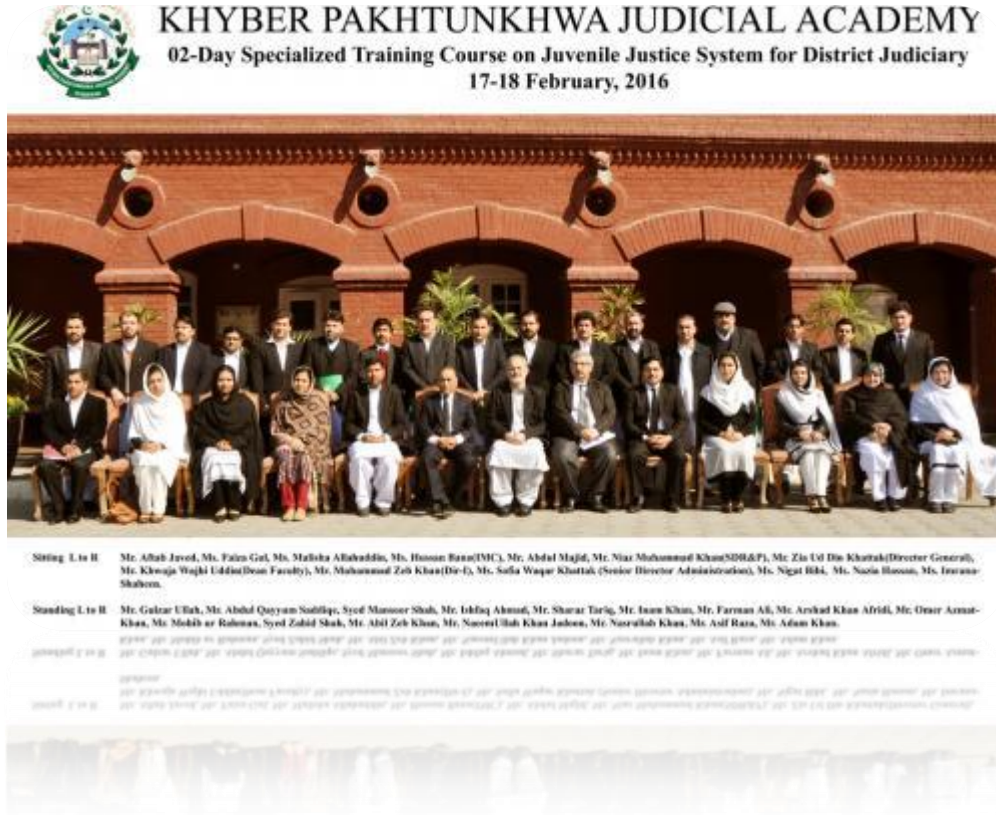
international pursuits. It indeed is a treat to read this book. The book is published by Federal Law House Rawalpindi/Lahore.
